Day Use Hours

The lands and facilities of Capital District State Park Units are hereby closed to public use, entry and occupancy except as provided below. Daily closing hours are posted at major public use areas and entry gates.

DAY USE HOURS

Regular day use hours for Old Sacramento State Historic Park are:

SUNRISE TO SUNSET seven days a week year round

Regular day use hours for Sutter's Fort State Historic Park and California State Indian Museum's exterior grounds bordered by K Street to the North, 28th Street to the East, L Street to the South and 26th Street to the West are:

SUNRISE TO SUNSET seven days a week year round

Regular day use hours for the grounds at Railtown 1897 State Historic Park (18115 5th Avenue Jamestown, CA) are:

SUNRISE TO SUNSET seven days a week year round

Regular day use hours for the buildings and interior grounds of Sutter's Fort State Historic Park (2701 L Street, Sacramento, CA) and the California State Railroad Museum (125 I. Street, Sacramento, CA) are:

10:00 am to 5:00 pm seven days a week year round except for Thanksgiving, Christmas and New Year's Day

Regular day use hours for Leland Stanford Mansion State Historic Park (800 N. Street, Sacramento, CA), Governor's Mansion State Historic Park (1526 H. Street, Sacramento, CA), and the interior grounds of the California State Indian Museum (2618 K Street, Sacramento, CA) are:

10:00 am to 5:00 pm Wednesday through Sunday year round except for Thanksgiving, Christmas, and New Year's Day

Regular day use hours for the buildings and facilities of Railtown 1897 State Historic Park (18115 5th Avenue Jamestown, CA) are:

9:30 am to 4:30 pm April through October

10:00 am to 3:00 pm November through March except for Thanksgiving, Christmas, and New Year's Day

Exceptions to this order may be granted in writing by the District Superintendent or designee, Capital District, 101 J Street, Sacramento, CA 95814.

Nothing herein shall affect any existing private contract or property rights.

Nothing herein shall be construed in derogation of other provisions of law.
